Drawing on his diverse experience in federal and state government, including as a captain in the US Army Reserve JAG Corps and counselor to senior elected leaders, Matt strategically advances client priorities in government-facing matters.

Separately, over the past decade, Matt has counseled senior government leaders—President Biden's campaign and transition team, then-Senator Kamala Harris, then-House Speaker Nancy Pelosi, Secretary of Energy Jennifer Granholm and CA Governors Gavin Newsom and Jerry Brown—on novel legal and policy issues. He has also served as oversight vice-chair for the Coast Community College District, stewarding \$700 million in long-term education investments for students and the local community.

After graduating salutatorian from UC Berkeley, Matt earned his JD from Yale Law School as a Paul & Daisy Soros Fellow, Coker Fellow for torts and legal writing, notes & comments editor of the Yale Law Journal, managing editor of the Yale Law & Policy Review, founding legislative/stakeholder advocate for the We Care Coalition, and director of the Education Adequacy Project Clinic. Following law school, he clerked for Justice Goodwin Liu on the California Supreme Court.
