With more than 30 years of first-chair trial experience, Mike has been recognized dozens of times for his work in commercial litigation, white collar, securities, and antitrust matters. A fellow in the American College of Trial Lawyers, Mike has been named one of the Top 100 Lawyers in California by the Daily Journal, a “Game Changer” by The Recorder, and a “White Collar MVP” by Law360. Mike’s courtroom savvy, his dedication to his clients, and his leadership presence have made him one of the most sought-out litigators in the United States.

Beyond his courtroom advocacy, Mike serves on Cooley’s Board of Directors and its Compensation Committee. From 2013 to 2024, Mike was global chair of Cooley’s Litigation Department, overseeing a period of unprecedented expansion, courtroom success, and economic growth. Mike’s strategic vision for the department included its expansion into new geographies and practice areas, as well as the addition of dozens of lateral partners from the most prominent United States Attorney’s Offices, federal agencies, and competing firms. During this period, the department cemented its reputation as the go-to firm for disruptors and innovative companies, culminating with its recognition by The American Lawyer as “the modern marvel” and “trusted partner of the new economy.”

One of the defining moments in Mike’s career was acting as co-trial counsel for baseball legend Roger Clemens in the obstruction of Congress and perjury prosecution brought against Clemens by the U.S. Attorney’s Office for the District of Columbia. After a nine-week trial, the jury returned not guilty verdicts on all six counts. Mike’s cross-examination of prosecution witness Andy Pettitte, a former teammate of Clemens, was called a key turning point in the trial by several observers. Throughout the trial and in his closing argument, Mike also took the lead in debunking DNA evidence that prosecutors claimed linked Clemens to the use of performance-enhancing drugs.

Other notable representations include:

- Lead trial counsel for a publicly traded financial services company in a breach of contract trial in the Southern District of California concerning alleged improper disclosures made by the company in an SEC filing regarding the termination of its former Vice President and General Counsel. The jury trial victory was described by one media outlet as one of the top defense verdicts in California.
- Lead trial counsel for a worldwide electronics company defending against fraud and breach of contract claims in California Superior Court. After a lengthy trial, the jury ruled in favor of Cooley’s client on most claims and awarded damages to the client that exceeded plaintiff’s recovery. The case subsequently settled on favorable terms.
- Lead trial counsel for a former Big 5 accounting partner accused by the Justice Department with

conspiracy, securities fraud, and wire fraud in connection with the financial reporting of a global software company. The U.S. Attorney described the case as the largest fraud in the history of the Southern District of California. After two trials lasting nearly six months, both juries declined to convict Mike's client on a single count, and all charges were dismissed.

- Lead counsel for a dual Canadian-Israeli citizen who, while represented by prior counsel, pled guilty to a felony charge of money laundering based on his connection to a payment processing company that serviced an allegedly illegal online pharmacy. After voluminous briefing and an evidentiary hearing in which prior counsel testified for the government, the court granted the motion to withdraw the guilty plea, finding that there were "fair and just reasons" to do so.

For nearly a decade before he joined Cooley, Mike was a federal prosecutor in Washington, D.C., for the Public Integrity Section of the United States Department of Justice. He tried cases in federal courts around the country, including Texas, Ohio, Kentucky, Washington, D.C., and New York. He received the Department's most prestigious trial honor, the John Marshall Award for Trial of Litigation, along with several other commendations from federal law enforcement agencies. Mike's notable trials as a federal prosecutor include the following:

- The conviction of a former United States Congressman for racketeering, bribery, and illegal gratuities after a trial in the Western District of Texas. Mike also argued the appeal before the Fifth Circuit, and the conviction and sentence were affirmed.
- The conviction of a prominent Cleveland defense attorney for mail fraud and tax evasion after a trial in the Northern District of Ohio involving the attorney's solicitation of substantial amounts of money from a criminal defendant based on his promise to use the money to bribe a federal judge. Mike also argued the appeal before the Sixth Circuit, and the conviction and sentence were affirmed.
- The conviction of a senior Defense Intelligence Agency official for mail fraud after a trial in the District Court for the District of Columbia involving payments by a defense contractor to a third party with whom the official was involved in a romantic relationship.
- The conviction of a coal mining company and its owner for mail fraud after a trial in the Western District of Kentucky involving bid rigging on coal supply contracts at a public utility. Mike also argued the appeal before the Sixth Circuit.
- The conviction of a City Councilman and a Port Commissioner for bribery and mail fraud after a trial in the Southern District of Texas.

Mike currently serves as the Chair of the Standing Committee on Attorney Discipline for the Southern District of California, a position to which he was appointed by the District Court. He is a Board Member for the San Diego Volunteer Lawyer Program, the oldest and most comprehensive pro bono legal services program in San Diego County. Mike previously served as an Adjunct Professor at the University of San Diego School of Law, teaching an upper-level course on white collar and corporate crime. He speaks and publishes frequently about trial practice and white collar criminal issues, and he is routinely named among the best in his fields of practice by various publications.

Mike graduated from Stanford Law School in 1990 and thereafter served as a law clerk to Judge Rudi M. Brewster of the US District Court for the Southern District of California. He received his BA from Princeton University, where he captained the Men's Division I Soccer Team and played for future US Men's National Team Manager Bob Bradley.
