Thomas is a litigator who handles both civil and criminal matters. Before joining Cooley, Thomas served as a law clerk to Justice Malcolm Rowe of the Supreme Court of Canada. During law school, he won several awards at the Laskin, an administrative law moot competition, and clerked at the Court of Appeal of Quebec. Thomas also published an academic paper on statutory interpretation with former Canadian Supreme Court Justice Thomas Cromwell.
